Good morning Mr. Perkins,

As we discussed on the phone October 26, please provide your proposal for a payment plan. Your proposal should include:

- The proposed payment amount,
- The proposed number of payments,
- The date of the first payment, and
- The date each month of future payments.

When we spoke last week I suggested a minimum of \$200 a month for a maximum term of 24 months.

I've attached the judge's order in your case. Please ensure you are familiar with the terms of the order. You are required to either pay the \$4,000 penalty OR file jointly with UTC staff a proposed payment plan by October 20. If you fail to comply with any terms of the order the judge may impose the remaining \$16,000 of the penalty. Once we receive your proposed payment plan we will review it and make a recommendation to the judge. We can't do anything until we receive your proposed plan. We'd like to help.

Since time is of the essence, please email your proposed payment plan to [records@utc.wa.gov](mailto:records@utc.wa.gov) with a cc to me. I didn't receive your email initially because my email address was incorrect. The correct address is: [miturcot@utc.wa.gov](mailto:miturcot@utc.wa.gov)

In addition, the judge's order requires you to immediately cease and desist operations as a charter party and excursion carrier. By definition, operating includes advertising or offering charter or excursion services. This means you must remove all advertising, including online advertising. The alternative is for you to obtain a permit. I've attached an application for charter/excursion permit if you choose to go that route.
