RE: *In the Matter of the Application of We Like to Move It, Move It!! LLC for a Permit to Operate as a Motor Carrier of Household Goods – Docket TV-170176*

Dear Mr. Johnson:

On June 6, 2019, Josh Manion, owner of We Like to Move It, Move It!! LLC (Company) spoke with counsel for Commission Staff (Staff) concerning the brief adjudicative proceeding (BAP) in Docket TV-170176, scheduled for June 11, 2019. The June 11, 2019 BAP was set to adjudicate the Commission's Notice of Intent to cancel the Company's provisional permit as a household goods carrier, and to dismiss its application for permanent authority, due to the Company's ongoing failure to attend a Commission-sponsored household goods carrier training class, as required by WAC 480-15-305(1)(c).

During the call, Mr. Manion expressed his desire to attend the Commission-sponsored household goods carrier training taking place on August 7, 2019, at the Commission's headquarters, in lieu of proceeding with the June 11, 2019 BAP. Mr. Manion memorialized this understanding in an email message to Staff, which is attached. Based on this written assurance from the Company owner, Staff recommends that the Commission suspend the June 11, 2019 BAP and the procedural schedule in Docket TV-170176 in order to permit the Company the opportunity to come into compliance with WAC 480-15-305(1)(c) by attending the upcoming August 7, 2019 training.

Staff will file a status update with the Commission concerning the Company's compliance (i.e., attendance at the August 7, 2019 Commission-sponsored household goods carrier training) no later than August 9, 2019.
