DECLARATION OF  
RACHEL JONES

Rachel Jones, under penalty of perjury under the laws of the State of Washington, declares as follows:

1. I am employed by the Washington Utilities and Transportation Commission (Commission) as a Compliance Investigator in the Consumer Protection Section. As a Compliance Investigator, my responsibilities include conducting investigations regarding the business practices of regulated utility and transportation companies. As part of those duties, I investigate household goods carriers that may be operating without the required Commission permit.
2. On February 27, 2017, I received a telephone call from Bogdan Momotyuk at (253) 335-6601. Mr. Momotyuk stated that he is the owner of Bogdan Delivery L.L.C. and wanted to know what the criteria is for becoming a household goods carrier in Washington State. Mr. Momotyuk explained that he would be operating as a broker and he will contract with other moving companies in Washington to perform the residential household goods moves. I explained that whatever company he decides to contract with has to be a permitted household goods carrier with the commission. Mr. Momotyuk was referred to the Licensing Section for more information on submitting a household goods carrier application and the insurance requirements.
3. On February 28, 2017, an internet search for Bogdan Delivery L.L.C., produced a business advertisement. The website has advertisements for residential moving services within the state of Washington.<sup>1</sup>
4. On March 1, 2017, a search of Commission records, produced an active record for Bodgan Delivery, L.L.C. with a common carrier permit (CC-065898) issued on May 20, 2015. The common carrier permit excludes performing residential household goods services.<sup>2</sup>

5. On March 1, 2017, a compliance letter was sent to Bogdan Delivery L.L.C. requesting the company to cease and desist as a residential household goods carrier until the company obtains a household goods permit from the commission.<sup>3</sup>
6. On April 14, 2017, under an assumed name I requested a residential household goods moving quote from [www.bogdananddelivery.com](http://www.bogdananddelivery.com). I received a response back offering household goods moving services for \$500. The services include two movers, equipment, and a truck.<sup>4</sup>

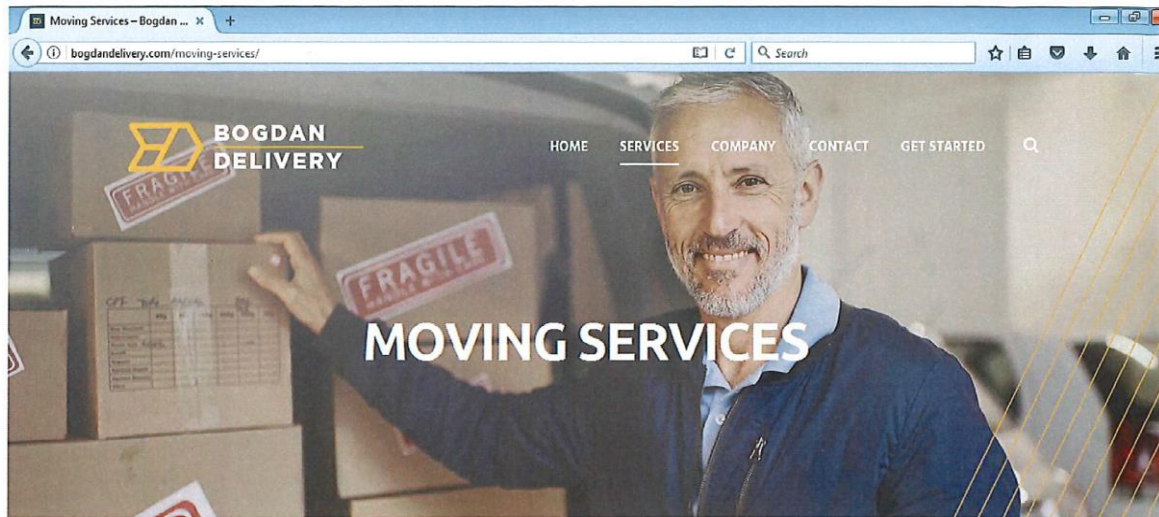

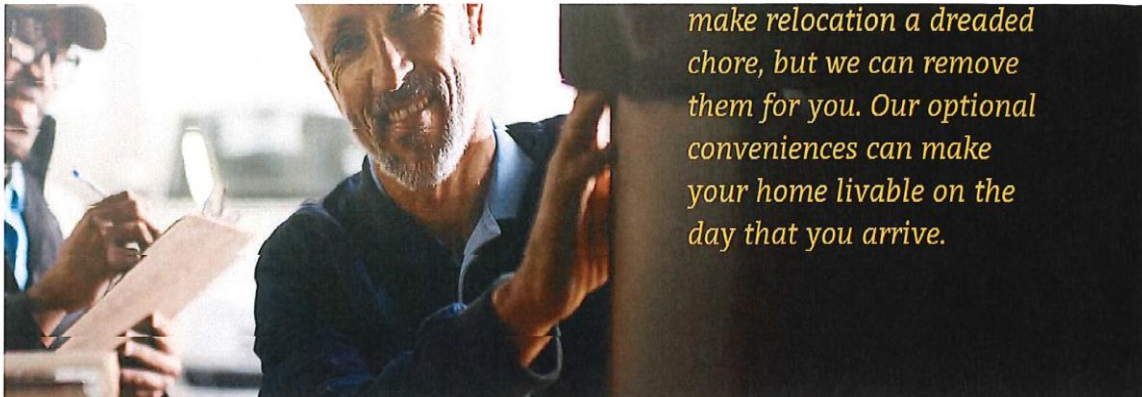

**RE: Household Goods Moving in Washington State**

Dear Mr. Momotyuk:

The Utilities and Transportation Commission has information that you are conducting household goods moves within the state of Washington. Advertisements for your household goods services have been found on [www.bogdandelivery.com](http://www.bogdandelivery.com). You do not have a valid permit, as required by state law, to conduct this type of work. Conducting household goods moves requires a permit issued by the commission.

Our records show that you currently have a common carrier permit (CC-065898) with the commission. The common carrier permit does not allow you to perform household goods moves.

To avoid enforcement action, your complete household goods permit application, supporting materials, and application fee must be submitted to the commission by **March 15, 2017**.

**Until you obtain a permit, you must immediately cease operating as a household goods mover in Washington State.** Operating as a household goods mover without the required permit is illegal and subject to a penalty of **\$5,000 per violation**. This means that you may receive this penalty for each day you operate in violation of the law.

**You must also immediately cease advertising as a household goods mover in Washington State.** Advertising for the transportation of property for compensation in Washington without a proper permit is against the law. The penalty for advertising without a permit is **\$5,000 per violation**. This means that you may receive a penalty for each and every advertisement. At this time, the commission has documented advertisements for household goods moving services from Bogdan Delivery LLC.

**If you advertise or operate as a household goods mover without a permit, the commission will take enforcement action against you.**

Such action may include the above-mentioned financial penalties; and you will be served with a subpoena and be required to appear before a judge.

Again, to avoid enforcement action, your complete application, supporting materials, and application fee must be submitted to the commission by **March 15, 2017**.

Should you decide to apply for a household goods moving permit, please note that you still may not operate as a household goods mover in Washington State until you have received a permit.
