Since passing the King County Ordinance for yardwaste, our drivers have tagged approximately 500 customers in the month of August.

We received 375 yardwaste sign up cards from customers who wanted to sign up or change cart sizes in the month of August.

In the Rural King Couny area our rates were approved on August 26, 1993. We proceeded to deliver recycle bins the following week (August 30 - September 3) according to what day of service customers had. We delivered 3 14-gallon bins and about 2 weeks later they received 1 lid for their bins. The following week (September 6 - September 10) we picked up the recycling for the first time.

Since implementing recycling in Rural King County we have great success with people signing for both residential garbage service and for recycling only service. If ever people need bins we do have plenty on hand to deliver out to the customer on their next pick up day.
