Dear Ms. Washburn:

I am the lead petitioner in the above docket (the "Rupp" docket). A Notice dated November 10, 2005 suspended the procedural schedule for this docket. Petitioners are writing to request that the procedural schedule be resumed.

The schedule was suspended pending a Commission decision in Docket No. UT-050814, In the Matter of the Joint Application of Verizon Communications, Inc. and MCI, Inc. for Approval of Agreement and Plan of Merger, (the "Merger" docket). Final Order No. 07 in the Merger docket rejected the proposed settlement for the Rupp docket as part of the merger. Paragraph 99 of the order states:

We find that the Rupp petition should not be resolved as a condition of the merger. It is the subject of a pending docket, and contains issues that should be resolved on the basis of facts and legal issues to be determined in that proceeding.

I attempted to contact the other parties, as set forth in the attached email, requesting their input and concurrence on the resumption but have yet to receive any replies. Petitioners would prefer to have the schedule resumed without delay.
