Dear Mr. Danner:

It has come to the attention of Puget Sound Energy, Inc. ("PSE") that the MS Word versions of two documents filed in the above-referenced dockets contain embedded comments and revision marks that are not a part of the filed testimony and that include an attorney-client privileged communication. These embedded comments and revision marks are not present on the paper copies or PDF versions of the filed documents—they are present only on the MS Word versions of the documents. The electronic MS Word documents at issue are:
