TO ALL INTERESTED PERSONS:

On June 29, 2022, Puget Sound Pilots (PSP) filed with the Washington Utilities and Transportation Commission (Commission) proposed revisions to its currently effective Pilotage Tariff No. 1. PSP characterizes this filing as a general rate case.

On July 15, 2022, the Commission entered Order 01, Complaint and Order Suspending Tariff Revisions. The Commission suspended the operation of PSP's tariff revisions and initiated an adjudication in this proceeding. The Commission convened an initial prehearing conference on August 4, 2022.

On August 26, 2022, the Commission entered Order 03, Prehearing Conference Order; Notice of Hearing (Order 03). Order 03 established the procedural schedule for this proceeding including an evidentiary hearing beginning on Wednesday, February 22, 2023.

On October 18, 2022, the Commission entered Order 04, Granting Motion for Leave to File Reply; Granting Motion for Leave to Supplement the Record (Order 04). Order 04, among other things, granted a four-week extension to the procedural schedule of this adjudication and provided that the Commission would schedule a second prehearing conference to establish new deadlines and a new hearing date by separate notice.
