Dear Ms. Washburn:

We have received a petition for re-hearing regarding the above docket and the final adjudicative order presented from Administrative Judge Berg.

After discussing this situation with our counsel we have been advised that a petition for reconsideration can not stay the final order per RCW 34.05.470 section 1, subsection 2.\*

Our counsel advises us that the charges given to Ms. Taut are correct and have been affirmed correct by Ms. Tani Thurston of the Utilities Commission and that the correct course of action would to require that Ms. Taut adhere to the order imposed.

Ms. Taut indicates in her petition to rehear this case that All My Sons did not fully comply with the order in submitting her a final billing within 3 days of the date of her final order. This is false, as the commission is aware of our attempts to deliver this final billing to Ms. Taut via Airborne Express to address provided to us by the commission, in addition to sending her a letter to her Post Office box. Furthermore, All My Sons sent via certified mail the final billing to Ms. Taut's Post Office box when we learned that she did not reside at the address given to the commission.

Ms. Taut further indicates that All My Sons is attempting to create "chaos" and "Diversion" in settling this. Again, this is incorrect as All My Sons is wishing to proceed quickly to settle this matter within the requirements of the final order.


Therefore, All My Sons is formally requesting that the commission indicate to Ms. Taut that she must comply with the order and present payment to All My Sons Moving & Storage.

If Ms. Taut, upon notification, is unwilling or unable to provide payment to All My Sons via Cash, Cashiers Check, Money Order, or Certified Check, we request that this be placed within the commissions record to substantiate our position in this matter.

Should the commission deem that a rehearing is required, All My Sons will provide additional testimony.
