- *I* NATURE OF PROCEEDING. Docket UE-061411 involves a request by Avista Corporation for approval for an update to the Company's base power supply (production) and transmission costs.
- CONFERENCE. The Washington Utilities and Transportation Commission (Commission) convened a prehearing conference in this docket at Olympia, Washington on September 27, 2006, before Administrative Law Judge C. Robert Wallis.
- 3 APPEARANCES. David Meyer, attorney, Spokane, Washington, represents Avista Corporation (Avista). Judith Krebs, Assistant Attorney General, Seattle, Washington, represents the Public Counsel Section of the Washington Office of the Attorney General (Public Counsel). Robert D. Cedarbaum, Assistant Attorney General, Olympia, Washington, represents the Commission's regulatory staff (Commission Staff or Staff).<sup>1</sup> Melinda Davison and Bradley Van Cleve, attorneys, Davison Van

There is an *"ex parte* wall" separating the Commissioners, the presiding Administrative Law Judge, and the Commissioners' policy and accounting advisors from all parties, including Staff. *RCW* 34.05.455.

Cleve, Portland, Oregon, represent Petitioner Industrial Customers of Northwest Utilities (ICNU). Contact information provided at the conference for the parties' representatives is attached as Appendix A to this order. Contact information for staff members who should receive copies of distributed material is attached as Appendix B. Persons on this list are not formal representatives for legal or individual rights of the parties, but the parties ask that they receive electronic mail notification for purposes of maintaining a current record.

- 4 PETITIONS FOR INTERVENTION. Industrial Customers of Northwest Utilities petitioned in writing to intervene in the docket. No party objected to the petition. The Commission finds that the petitioner has established a substantial interest in this proceeding and that its participation will be in the public interest. The petition to intervene is granted. The Commission received no other requests to intervene in this docket.
- 5 PROTECTIVE ORDER. The parties ask that the Commission enter a protective order in this docket under RCW 34.05.446, RCW 80.04.095, WAC 480-07-420 and WAC 80-07-423 to protect the confidentiality of proprietary information. The request was granted and a protective order has been entered in this docket.
- 6 DISCOVERY. The parties asked that the discovery rules be invoked in this docket consistent with WAC 480-07-400. The matter is one that qualifies for discovery. The discovery rules, WAC 480-07-400 through 425, are invoked. Beginning with the filing of staff and intervenor direct evidence on January 13, 2007, the time for response to discovery requests is five business days.
- 7 **DISPOSITIVE MOTIONS.** Intervenor ICNU and Public Counsel indicated a desire to file dispositive motions. They propose to challenge the propriety of the Company's filing, arguing that it constitutes a general rate case filing without complying with the procedural requirements for such a filing, or that it constitutes an improper "single issue rate case."
- 8 **PROCEDURAL SCHEDULE.** The parties failed to agree upon a procedural schedule during the conference. The matter was argued, and the presiding administrative law judge determined a procedural schedule, to which the parties

expressed assent. The Commission adopts the following procedural schedule, which is also attached to this Order as Appendix C. If the Commission grants a motion for summary determination, changes may be necessary to portions of the following schedule beginning with the filing of staff, public counsel, and intervenor testimony.

- 9 NOTICE OF HEARING. The Commission will hold evidentiary hearings in this matter beginning Monday, February 12, 2007, at 9:30 a.m. in the Commission's Hearing Room, Second Floor, Chandler Plaza Building, 1300 S. Evergreen Park Drive S. W., Olympia, Washington.
- 10 NOTICE OF PREHEARING CONFERENCE. The Commission will convene a prehearing conference in this matter on Thursday, February 8, 2007, at 1:30 p.m. in the Commission's Hearing Room, Second Floor, Chandler Plaza Building, 1300 S. Evergreen Park Drive S. W., Olympia, Washington to mark exhibits, including exhibits on cross examination, if any, and to address any procedural matters that the parties may present. If no matters warrant attention, the conference will be cancelled.

<sup>&</sup>lt;sup>2</sup> Public Counsel, in consultation with the Commission's public affairs staff, other parties, and the Administrative Law Division, will no later than October 27 recommend a date and location for a hearing for members of the public to comment on the proposed rate increase.

- 11 DOCUMENT PREPARATION AND FILING REQUIREMENTS. Parties must file an original plus 8 copies of all pleadings, motions, briefs, and other prefiled materials. These materials must conform to the format and publication guidelines in WAC 480-07-395 and WAC 480-07-460. The Commission prefers that materials be three-hole punched with *oversized* holes to allow easy handling. The Commission may require a party to refile any document that fails to conform to these standards.
- 12 All filings must be mailed or delivered to the Executive Secretary, Washington Utilities and Transportation Commission, P.O. Box 47250, 1300 S. Evergreen Park Drive, S.W. Olympia, Washington 98504-7250. Both the post office box and street address are required to expedite deliveries by the U.S. Postal Service.
- 13 An electronic copy of all filings must be provided through the Commission's Web Portal (www.wutc.wa.gov/e-filing) or by e-mail delivery to <records@wutc.wa.gov>. Alternatively, parties may furnish an electronic copy by delivering with each filing a CE or a 3.5-inch IBM-formatted high-density diskette including the filed document(s). Parties should furnish electronic copies in .pdf (Adobe Acrobat) format, supplemented by a separate file in MS Word 6.0 (or later), or WordPerfect 5.1 (or later) format. Parties are required to follow WAC 480-07-140(5) in organizing and identifying electronic files.
- 14 ELECTRONIC SUBMISSION OF DOCUMENTS. Pursuant to WAC 480-07-145(6) the presiding officer may grant parties a one-day extension of the paper-filing requirement, allowing electronic submission of documents with the Commission on the filing deadline. Parties may only submit documents electronically with the Commission in this proceeding with the permission of the presiding officer. If, at any time during this proceeding, parties are authorized to submit documents with the Commission electronically under WAC 480-07-145(6), parties must submit the document through the Commission's Web portal (www.wutc.wa.gov/e-filing) or by email to records@wutc.wa.gov, and file an original, plus 8 copies, of the document with the Commission by the following business day. Finally to perfect filing, parties must provide courtesy copies of filings to the presiding officer and advisory staff, as well as the parties to the proceeding.

- 15 ELECTRONIC SUBMISSION OF DOCUMENTS. Pursuant to WAC 480-07-145(6) the presiding officer granted a one-day extension of the paper-filing requirement, allowing parties to submit documents to the Commission electronically on the filing deadline. Parties may submit documents electronically either through the Commission's Records Center Web Portal (www.wutc.wa.gov/e-filing) or via email to records@wutc.wa.gov, and must file an original, plus 8 paper copies, of the document with the Commission by the following business day. Finally, to perfect filing, parties must provide courtesy copies to the presiding administrative law judge and advisory staff as well as the parties to the proceeding. PLEASE NOTE: The one-day extension of paper filing is NOT the rule of the case, and is not available in the absence of PRIOR authorization from the presiding officer. Parties should request permission at least 48 hour prior to the stated filing deadline.
- 16 ALTERNATE DISPUTE RESOLUTION. The Commission supports the informal settlement of matters before it. Parties are encouraged to consider means of resolving disputes informally. The Commission does have limited ability to provide dispute resolution services; if you wish to explore those services, please call the Director, Administrative Law Division, at 360-664-1142.
- 17 NOTICE TO PARTIES: Any objection to the provisions of this Order must be filed within ten (10) days after the service date of this Order, pursuant to WAC 480-07-430 and WAC 480-07-810. Absent such objection, this Order will control further proceedings in this matter, subject to Commission review. Parties must provide courtesy copies of filings to the presiding administrative law judge.
