Dear Ms. Maxwell:

In accordance with the Commission's policy statement in Docket UG-120715, Cascade Natural Gas Corporation ("Cascade" or "Company") hereby submits its update to the Cost Recovery Mechanism with actual costs as of September 30, 2022, and estimated costs through October 31, 2022. The proposed effective date is November 1, 2022.

The proposed tariff will result in an annual revenue increase of approximately \$1.2 million or .38 percent. The average impact to a residential customer using 54 therms per month will be an increase of \$0.25 per month or .41 percent. The average monthly residential bill will increase from \$61.00 to \$61.25.

A number of the worksheets included in this filing contain valuable commercial information. Cascade respectfully requests protection and confidential treatment of the attached confidential information under Chapters 42.17 RCW, RCW 80.04.095 and WAC 480-07-160. Public disclosure of this information would result in private loss, including an unfair competitive disadvantage, which would negatively affect the Company's shareholders.
