## STATUTES RELATING TO WUTC AUTHORITY TO REGULATE CLEARANCES.

§ 80.01.040. General powers and duties of commission

The utilities and transportation commission shall:

(1) Exercise all the powers and perform all the duties prescribed therefor by this title and by Title 81 RCW, or by any other law.

(2) <u>Regulate in the public interest, as provided by the public service laws, the</u> rates, services, <u>facilities</u>, and practices <u>of</u> all persons engaging in the transportation by whatever means of persons or property within this state for compensation, and related activities; including, but not limited to, air transportation companies, auto transportation companies, express companies, freight and freight line companies, motor freight companies, motor transportation agents, private car companies, <u>railway companies</u>, sleeping car companies, steamboat companies, street railway companies, toll bridge companies, storage warehousemen, and wharfingers and warehousemen.

(3) Regulate in the public interest, as provided by the public service laws, the rates, services, facilities, and practices of all persons engaging within this state in the business of supplying any utility service or commodity to the public for compensation, and related activities; including, but not limited to, electrical companies, gas companies, irrigation companies, telecommunications companies, and water companies.

(4) <u>Make such rules and regulations as may be necessary to carry out its other powers and duties</u>.

§ 81.04.387. Penalties -- Violations by other corporations

Every corporation, other than a public service company, which shall violate any provision of this title, or which shall fail to obey, observe or comply with any order of the commission under authority of this title, so long as the same shall be and remain in force, shall be subject to a penalty of not to exceed the sum of one thousand dollars for each and every offense. Every such violation shall be a separate and distinct offense, and the penalty shall be recovered in an action as provided in RCW 81.04.400.

§ 81.28.010. Duties as to rates, services, and facilities

Page 1 - Statutes

All charges made for any service rendered or to be rendered in the transportation of persons or property, or in connection therewith, by any common carrier, or by any two or more common carriers, shall be just, fair, reasonable and sufficient.

<u>Every common carrier shall</u> construct, furnish, <u>maintain and provide</u>, <u>safe</u>, <u>adequate and sufficient</u> service facilities, <u>trackage</u>, <u>sidings</u>, railroad connections, <u>industrial and commercial spurs</u> and equipment <u>to enable it to promptly</u>, expeditiously, <u>safely and properly receive</u>, <u>transport and deliver</u> all persons or property offered to or received by it for transportation, and to promote the safety, <u>health</u>, comfort and convenience of its patrons, employees and the public.

All rules and regulations issued by any common carrier affecting or pertaining to the transportation of persons or property shall be just and reasonable.

§ 81.28.240. Commission may order improved facilities and service

<u>Whenever the commission shall find</u>, after such hearing, <u>that the</u> rules, regulations, practices, equipment, appliances, <u>facilities or service of any such common carrier</u> in respect to the transportation of persons or property <u>are</u> unjust, unreasonable, <u>unsafe</u>, improper, inadequate or insufficient, <u>the commission shall determine the</u> just, reasonable, <u>safe</u>, <u>adequate</u>, <u>sufficient and</u> <u>proper rules</u>, <u>regulations</u>, practices, equipment, appliances, <u>facilities</u> or service <u>to be observed</u>, furnished, <u>constructed or enforced</u> and be used in the transportation of persons and property by such common carrier, and fix the same by its order or rule.

§ 81.44.010. Commission may order improved facilities

<u>Whenever the commission shall</u>, after a hearing had upon its own motion or upon complaint, <u>find</u> that, additional tracks, switches, terminals, terminal facilities, stations, motive power or any other property, apparatus, equipment, <u>facilities or device for use by any common carrier</u> in, or in connection with the transportation of persons or property, <u>ought reasonably to be provided</u>, or any repairs or improvements to, or changes in, any theretofore in use ought reasonably to be made, or any additions or changes in construction should reasonably be made thereto, in order to promote the security or convenience <u>of</u> the public or <u>employees</u>, or in order to secure adequate service or facilities for the transportation of passengers or property, <u>the commission may</u>, after a hearing, either on its own motion or after complaint, <u>make and serve an order directing such repairs</u>, improvements, changes or additions to be made.

§ 81.44.065. Devolution of powers and duties relative to safety of railroads

Page 2 - Statutes

<u>The utilities and transportation commission shall exercise all powers and duties in relation to the inspection of tracks</u>, bridges, structures, equipment, apparatus, and appliances <u>of railroads with respect to the safety of employees</u> and the public <u>and the administration and enforcement of all laws</u> providing for the protection <u>of</u> the public and <u>employees</u> of railroads which prior to April 1, 1955 were vested in and required to be performed by the director of labor and industries.
