#### **WN U-76**

The Commission's Order 08/06 authorized a revenue requirement increase of \$12.68 million to the Company's base rates for Rate Year 1. Consistent with the Order, the Company has updated the net power cost forecast, and this results in a revised revenue requirement increase of \$10.9 million. Schedule 92 contains the adjustment for both the Coal Facilities Tracker identified in ¶12 of Attachment A to Order 08/06 and the Fly Ash tracker identified in ¶16 of Attachment A to Order 08/06.

Enclosed as Attachment A is the estimated effect of the price changes, including billing determinants and monthly billing comparisons. The average residential customer using 1,200 kWh per month will see an increase of \$4.84 per month. Additionally enclosed is a revised estimate of incremental reclamation and depreciation costs as Attachment D in this filing consistent with ¶320 of Order 08/06.

Please note that some of the workpapers are designated confidential in accordance with WAC 480-07-160 and Protective Order 02 issued in this docket and are being provided electronically to the Commission and parties who have signed the protective order. PacifiCorp has marked pages containing confidential information as "Shaded information is designated as confidential per the Protective Order and WAC 480-07-160."
