Sierra Club Data Request 1.2

Refer to the Direct Testimony of Shelly McCoy, page 21 at 3-4.

- (a) Clarify whether the company proposes to fully depreciate Jim Bridger plant by 2025.
- (b) When (i.e. provide a date) did the company decide that it was reasonable to adjust the depreciation date for the Jim Bridger plant to 2025 in Washington state?
- (c) Does the company plan to retire any or all of the Jim Bridger units by the end of 2025?
- (d) If the company does not propose to retire all of the Jim Bridger units at the end of 2025, please describe how the company proposes to treat generation from Jim Bridger units after 2025 with respect to Washington state.
- (e) Please describe how the company will treat each of the Jim Bridger units in long-term planning for any year after 2025 in Washington state.
- (f) Has the company performed any economic analysis of installing SCR at Jim Bridger units 3 & 4 (similar to the analysis presented by Mr. Rick Link) with the assumption that generation from Jim Bridger could cease operation after 2025? If yes, please provide that analysis.
- (g) Has the company performed any economic analysis of installing SCR at Jim Bridger units 3 & 4 (similar to that presented by Mr. Rick Link) with the assumption that Jim Bridger is fully replaced in 2025? If yes, please provide that analysis.

Sierra Club Data Request 1.2 – 1st Supplemental

On January 22, 2016, Sierra Club requested the following clarification of the Company's response to subpart (f):

Original subpart (f) - Has the Company performed any economic analysis of installing SCR at Jim Bridger Units 3 & 4 (similar to the analysis presented by Mr. Rick Link) with the assumption that generation from Jim Bridger could cease operation after 2025? If yes, please provide that analysis.

Clarifying request for subpart (f) - Please confirm that the Company has not performed any economic analysis evaluating the installation of SCR at Jim Bridger Units 3 & 4 with the assumption that Jim Bridger would cease operation on or before January 1, 2026. To the extent such a study exists, please provide a supplemental response to SC 1-2(f) and provide the study.
