Re: Docket UE-200420—PacifiCorp’s Amended 2023 Integrated Resource Plan

PacifiCorp d/b/a Pacific Power & Light Company (PacifiCorp or Company) submits for filing its Amended 2023 Integrated Resource Plan (IRP), which also serves as the Company’s 2021 IRP Two-Year Progress Report. On March 31, 2023, PacifiCorp filed its initial 2023 Integrated Resource Plan (2023 IRP) in the above-referenced docket. An extended comment period was agreed to for the benefit of the Company and stakeholders allowing for feedback and amended materials to be considered for this Amended 2023 IRP on May 31, 2023. In response to feedback and additional development work, PacifiCorp is submitting a fully updated 2023 IRP inclusive of the Supplemental filing of sensitivities made on May 1, 2023. In this filing, PacifiCorp has made the following updates:

- Includes supplemental sensitivity studies
- Correction to Portfolio 06 (P06) – no forward technology
- Restatement of present value revenue requirement (PVRR) based on model updates
- Addition of two user requested studies
 - Allow gas to have a 40-year economic life and review selections
 - Retire coal by 2030, but leave gas to retire endogenously
- Additional expected case medium natural gas price and medium CO₂ price assumptions (the “MM” price-policy scenario) studies evaluated under alternative price curve futures
- Expanded Appendix I
- Expanded Appendix J
- Addition of Appendix N – includes flexible hydrogen production analysis
- Expansion of narrative in response to stakeholder feedback

The Company will provide a follow-up supplemental filing containing all public, confidential, and highly confidential workpapers on or around June 14, 2023. This Amended 2023 IRP and the supplemental workpapers that will be filed in June will update the initial 2023 IRP filing, supplemental sensitivities filing, and all related workpapers in their entirety.
