Amendment Number: 5

Description of amendment: This Amendment deletes, changes and adds terms and conditions for certain UNEs as set forth in Attachment 1 and Exhibit A to this Amendment.

The amendment amends the interconnection agreement approved by the Commission on February 14, 2001 in WUTC Docket No. UT-013009 between Qwest Corporation and Pac-West Telecomm, Inc. That agreement was originally approved by the Commission on September 29, 1999 in WUTC Docket No. UT-990379 between Qwest Corporation and Northwest Telephone, Inc.

Company A represents that the amendment does not discriminate against non-party carriers, that it is consistent with state and federal law, and that it is in the public interest. By virtue of Company B's signature on the amendment, Company A believes that Company B agrees with these representations.
