t 3 to the Telecommunications Services Agreement (Contract No. TSA010302-1) (Agreement) by and between MCI WORLDCOM Network Services, Inc., a Delaware corporation, with offices at 6929 N. Lakewood Avenue, Tulsa, Oklahoma 74117 ("Provider"), and Verizon Global Networks Inc., a Delaware corporation, with offices at 6665 N. MacArthur Boulevard, Irving, Texas 75039 ("Customer") shall be effective on the date set forth below.

1. EFFECTIVE DATE

This Amendment 3 shall be effective January 1, 2002.

2. AGREEMENT MODIFICATION

- 2.1 Exhibit C, Page C-28, Section 26.3.9 (Additional Installation/Maintenance/Engineering).

Add the following sentence below the table:

"Normal hours shall be defined as 8:00 AM until 11:00 PM (Central time zone), Monday through Friday."

- 2.2 Exhibit C, ADD a new Section 33 (ACCESS BASED BILLING (ABB) CARRIER TERMINATION Service) and Attachment C-14.

Section 33 language is set forth in **Attachment 1** to this Amendment 3.

Attachment C-14 is set forth in **Attachment 2** to this Amendment 3.

- 2.3 Exhibit C, Attachment C-6, Page C-63, Section 4 (DIRECTORY ASSISTANCE).

Directory Assistance calls equals or exceeds twelve thousand five hundred (12,500), the above rate for domestic intrastate Directory Assistance shall be reduced by \$0.0100 per call. Canadian Directory Assistance is not subject to the rate reduction described herein.

Except as specifically amended herein, the terms and conditions of the Agreement, including any Amendments thereto, shall remain in full force and effect during the term of the Agreement.

32.3.3 Installation may be scheduled between the hours of 8 AM and 7 PM ET, Monday through Friday (excluding holidays). If installation is required outside of these hours, there is an additional fee of \$500. Customer agrees to pay the non-recurring installation charges for Dedicated Internet Services provided by Provider hereunder as shown on **Attachment C-13** with respect to the Services shown.

32.4 Dedicated Internet (Broadband) Discounts

Broadband services are defined as Frame Relay, ATM and/or Dedicated Internet products. The broadband discount applies to the combined total monthly recurring broadband revenues. A 34% discount shall apply to the Internet Port monthly recurring base rates set forth in **Attachment C-13**.

32.5 Acceptable Use

All use of the UUNET network and the service must comply with the then-current version of the UUNET Acceptable Use Policy (the "Policy") which is made a part of this Agreement and is available at the following URL: www.uu.net/usepolicy. Provider reserves the right to amend the Policy from time to time, effective upon posting of the revised Policy at the URL or other notice to Customer. Provider reserves the right to suspend the service or terminate this Agreement effective upon notice for a violation of the Policy. Customer agrees to indemnify and hold harmless Provider from any losses, damages, costs or expenses resulting from any third party claim or allegation ("Claim") arising out of or relating to use of the service, including any Claim which, if true, would constitute a violation of the Policy.

33. ACCESS BASED BILLING (ABB) CARRIER TERMINATION SERVICE

ACCESS BASED BILLING CARRIER TERMINATION Service is Provider's termination of calls received from Customer's Service Interconnection(s), as defined in Section 33.2 below, (i) subject to the limitation of origination and termination locations set forth herein, and (ii) for the charges and applicable discounts set forth herein.

33.1 Limitation of Origination and Termination Locations: ACCESS BASED BILLING CARRIER TERMINATION Service may be originated from any Provider POP and terminated to any direct dialable location worldwide.

33.2 Service Interconnections: In order to utilize ACCESS BASED BILLING CARRIER TERMINATION Service, one or more full time dedicated connections between Customer's network and the Provider network at one or more Provider designated locations ("**Provider POP**") must be established ("**Carrier Service Interconnection(s)**"). Each Carrier Service Interconnection shall be comprised of one or more dedicated access circuits, as the case may be. Carrier Service Interconnection(s) are sometimes referred to as "**Service Interconnections**". See **Exhibit C**, subsections 1.7.2 through 1.7.7 of this Agreement for additional information pertaining to Service Interconnections.

- 33.3 Start of Service: Start of Service for ACCESS BASED BILLING CARRIER TERMINATION Service will be concurrent with the activation of each circuit comprising a Carrier Service Interconnection (as defined herein) relevant to ACCESS BASED BILLING CARRIER TERMINATION Service.
- 33.4 Billing Increments: All calls (excluding California IntraLATA and California intrastate calls and calls to International Locations, Canada and Mexico) will be billed in six (6) second increments and subject to a six (6) second minimum charge. California IntraLATA and California intrastate calls will be billed in six (6) second increments and subject to an eighteen (18) second minimum charge. Calls to International Locations and Canada will be billed in six (6) second increments and subject to a thirty (30) second minimum charge. Calls to/from Mexico will be billed in sixty (60) second increments and subject to a sixty (60) second minimum charge. All calls will be billed utilizing Hardware Answer Supervision where available.
- 33.5 PIU CERTIFICATION: With respect to a Carrier Service Interconnection as defined in this Agreement, absent the automatic number identification (“ANI”) of the calling party, Customer shall provide Provider with a written certification (the “**Certification**”) of the percentage of interstate (including international) and intrastate minutes of use relevant to the minutes of traffic to be terminated in the same state in which the Provider POP is located to which the Carrier Service Interconnection is made. This Certification shall be provided by Customer prior to Start of Service for any Carrier Service Interconnection and may be modified from time to time by Customer and subject to recertification upon the request of Provider which requests shall not be made unilaterally by Provider more than once each calendar quarter. Any such modification(s) or Certification(s) shall be effective as of the first day of any calendar month and following at least forty-five (45) days notice from Customer. In the event Customer fails to make such Certification, the relevant minutes of use will be deemed to be subject to the Intrastate Rates described herein. In the event Provider or any other third party requires an audit of Provider's interstate/intrastate minutes of traffic, Customer agrees to cooperate in such audit at its expense and make its call detail records, billing systems and other necessary information reasonably available to Provider or any third party solely for the purpose of verifying Customer's interstate/intrastate minutes of traffic. Customer agrees to indemnify Provider for any liability Provider incurs in the event Customer's Certification is different than that determined by the audit.
- 33.6 ACCESS BASED BILLING CARRIER TERMINATION Service Charges: The rates and charges shown on the Schedules in **Attachment C-14** are per minute (except for the DIRECTORY ASSISTANCE charges which are per call) and will be determined based on the terminating location.

ACCESS BASED BILLING CARRIER TERMINATION Service rates described herein will apply to minutes provided to Verizon Wireless (Customer's Affiliate) described in RFP #750-67676-2001. Further, minutes currently being provided to Verizon Wireless under this Agreement (i.e., minutes that are currently subject to TRANSCEND CARRIER TERMINATION rates) will be subject to the ACCESS BASED BILLING CARRIER TERMINATION Service rates described herein effective as of the date Customer executes an agreement with Verizon Wireless; provided, however, the rates will not be implemented until the first day of the

month following the date Customer notifies MCI in writing that such an agreement has been signed.

All CARRIER TERMINATION accounts established on or after March 1, 2002 ("New Termination Accounts") will be subject to, at Customer's election, either the ACCESS BASED BILLING CARRIER TERMINATION Service rates described herein or the TRANSCEND CARRIER TERMINATION Service rates set forth in this Agreement. Further, any existing TRANSCEND CARRIER TERMINATION account being provided under this Agreement, may convert, at Customer's election, to the ACCESS BASED BILLING CARRIER TERMINATION Service rates. The election will be effective the first of the month following at least (5) days written notice.

The applicable OCN will be determined by the terminating ANI or the Local Routing Number.

The applicable "Class" shown on the Schedules will be determined as follows:

- (i) Class 1 = 9000 and 5000 series OCNs that are assigned to entities recognized by Provider as a Regional Bell Operating Company (RBOC)
- (ii) Class 2 = OCNs other than those specified in Class 1 (i.e., 9000 and 5000 series OCNs assigned to non-RBOCs, Class 3 or Class 4)
- (iii) Class 3 = Provider and its affiliates' OCNs
- (iv) Class 4 = GTE's OCNs
- (iv) Class 5 = Wireless OCNs that are assigned to entities recognized by Provider as Wireless Providers

Note: If calls are terminated to an entity in a particular Class that reflects "N/A" as the applicable rate, the applicable rate will be the default rate shown on the Schedule until such time as Provider has loaded the appropriate rate for such Class in the billing system.

The applicable Class designations are set forth in Provider's ACCESS BASED BILLING (ABB) OCN Table (the "**ABB OCN Table**"), which is available in the public area of Provider's Customer Access System/Bulletin Board (BBS). The ABB OCN Table may be modified from time to time thereby affecting Customer's applicable rates for ACCESS BASED BILLING CARRIER TERMINATION Service. Any modifications to the ABB OCN Table will be effective as of the first day of the month following its posting at the BBS."

1.5 Carrier Termination and Switchless International Rates

With respect to calls to be terminated to an International Location, if Provider routes the entire call, such call may be terminated via the following methods. In the event Customer does not have direct trunking to a particular country or the trunking to that country is at capacity, Customer will pass the call back to Provider who will terminate the call to the International Location (CARRIER TERMINATION Service rates apply). In the event the specified dedicated domestic trunk is unable to accept a call from Provider (i.e., trunk is at capacity or out of service), Provider will route the entire call including terminating the call to the International Location (SWITCHLESS Service rates apply).

With respect to calls terminating to an International Location utilizing CARRIER TERMINATION Service, the rates are set forth in **Attachment C-3** of this Agreement.
