This letter is to inform you of the progress made in the commission's rulemaking to consider the development of rules to implement SHB 2426 relating to delegation of certain commission decisions. This letter also provides notice of an opportunity to file written comments on proposed rules and participate in the formal rule adoption hearing.

On June 20, 2006, the commission filed a Notice of Proposed Rulemaking (CR-102) in this docket with the Code Reviser. The proposal would adopt new sections to chapter 480-07 WAC that would delegate authority to the executive secretary to decide certain matters and adopt 480-07-370 relating to probable cause decisions. The proposal also amends 480-07-825 by adding language relating to Initial order finality. This action begins the final part of the rulemaking process, which includes a written comment period, a public adoption hearing, and a decision by the commission.
