- 1 NATURE OF PROCEEDING. This proceeding arises out of a complaint filed by Commission Staff on July 3, 2014, against Olympic Moving & Storage, Inc., d/b/a Olympic Movers (Olympic Movers). The complaint alleges that Olympic Movers committed 320 violations of Commission rules and state laws.
- CONFERENCES. The Washington Utilities and Transportation Commission (Commission) convened a prehearing conference in this docket at Olympia, Washington on September 22, 2014, before Administrative Law Judge Gregory J. Kopta. The Commission subsequently entered Order 01, Prehearing Conference Order, on September 23, 2014, adopting a procedural schedule for this proceeding.
- 3 On November 14, 2014, Commission Staff (Staff) notified the Commission that the parties had made substantial progress towards resolution of all disputed items but agreed more time is needed to work out the final details of the settlement. Staff requested, on behalf of the parties, that the remaining procedural schedule in this matter be suspended and that the parties be permitted to file a settlement agreement by December 5, 2014.
- 4 On November 17, 2014, the Commission issued a notice suspending the procedural schedule and requiring the parties to file a settlement agreement or status report by December 5, 2014.

- 5 On December 5, 2014, Staff filed a status report stating that the parties had not reached a settlement agreement. Staff requested that the Commission convene a prehearing conference for the purpose of establishing a new procedural schedule pending execution of any settlement agreement.
- 6 On December 10, 2014, the Commission issued a notice of prehearing conference in this matter and convened a second prehearing conference on January 5, 2015, at 9:30 a.m.
- 7 **APPEARANCES.** Brett P. Shearer and Julian Beattie, Assistant Attorney General, Olympia, Washington, represent the Staff. Joseph A. Rehberger, Cascadia Law Group, Olympia, Washington, represents Olympic Movers.
- 8 **PROCEDURAL SCHEDULE.** The parties agreed on a new procedural schedule during the second prehearing conference. The Commission adopts this procedural schedule, which is attached to this Order as Revised Appendix B. All other provisions of Order 01 remain in full force and effect.
- 9 NOTICE OF HEARING; The Commission will hold an evidentiary hearing in this matter commencing on Monday, June 1, 2015, at 9:30 a.m., in the Commission's Headquarters, Room 206, Second Floor, Richard Hemstad Building, 1300 S. Evergreen Park Drive S.W., Olympia, Washington.
