This filing is made in in accordance with WAC 480-07-880; and in compliance with Washington Utilities and Transportation Commission (Commission) orders in dockets UG-230739 and UG-230819, following the Open Meeting held on December 21, 2023.

Purpose

The purpose of this filing is to provide the applicable tariff sheets listed in the table above to reflect the rate effects of Schedule 231 and Schedule 308 as approved in dockets UG-230739 and UG-230819, respectively.

The rate impacts of Schedule 231 and Schedule 308 were included in each of these respective dockets.

Background

On September 12, 2023, NW Natural, filed Advice No. 23-05, docketed as UG-230739, to introduce Schedule L, Schedule 231, and related tariff index pages for its proposed residential bill discount program. The Commission approved these tariffs and associated rates at its December 21, 2023 open meeting, as indicated in Order 01 in docket UG-230739.

On October 4, 2023, NW Natural filed Advice No. 23-14, docketed as UG-230819 to propose new tariff Schedule 308, Washington Climate Commitment Act Recovery Mechanism. The Commission approved this tariffs and associated rates at its December 21, 2023 open meeting, as indicated in Order 01 in docket UG-230819.

Proposed Changes

Exhibit A of this compliance filing reflects the addition of the approved rate changes adopted in dockets UG-230739 and UG-230819 to the general rate schedules listed in the table above.

Conclusion

NW Natural respectfully requests that the tariff sheet revisions listed in the table above, which have been revised in compliance with the Commission orders in docket UG-230739 and UG-230819, be approved with an effective date of January 1, 2024.
