- 1. The Public Counsel Unit of the Washington Attorney General's Office (Public Counsel) hereby offers this Public Comment Exhibit Bench Request No. 8 (BR-8) for admission into the record for this proceeding in Docket UG-230393 concerning the Tacoma Liquefied Natural Gas Tariff proposed by Puget Sound Energy (PSE or Company). On October 3, 2023, the Washington Utilities and Transportation Commission (UTC or Commission) issued a Notice of Virtual Public Comment Hearing (Notice), which was scheduled for 6 p.m. on November 1, 2023. The Commission and Public Counsel both received and compiled remarks from customers. Customers either provided comments to Public Counsel via emails or provided comments to the Commission through the UTC's online comment web portal.
- 2. <u>Public Comment Exhibit No. BR-8.</u> The Commission's Consumer Protection and Communications Staff documented these customer comments in a database matrix. The output from this database is included in .pdf format as Attachment 1 to this exhibit,³ and this file provides all comments submitted to the Commission. Public Counsel also received twenty-four

emailed written comments. These comments are included in Attachment 2.⁴ Public Counsel is also supplying an accumulative tally that totals each of the received comments and compares them to ones received by the Commission. For the totality of evidence we have included all comments in Public Counsel's Attachment 2, however the table below does not include duplicate comments in the overall total number of submitted comments referenced in paragraph five.⁵

The database matrix in Attachment 1 contains all comments the Commission received through their online web portal in response to the Notice up to November 6, 2023, the date of the evidentiary hearing. The Commission provided the output shown in Attachment 1 to Public Counsel on November 22, 2023.
