6	
7	JUDGE MOSS: Good morning, everyone. My name is
8	Dennis Moss. I'm an administrative law judge with the
9	Washington Utilities and Transportation Commission.
10	Some of you are known to me and know me, but we
11	will nevertheless begin our proceedings in the manner styled
12	WUTC against Avista, dockets UE-110876 and UG-110877,
13	consolidated, by taking appearances. So let's start with
14	Mr. Meyer.
15	MR. MEYER: Your Honor, appearing on behalf of
16	Avista is David Meyer, and my particulars are of record.
17	JUDGE MOSS: Yes. Yes. We will take the short
18	form this morning. Let's go ahead and get in Mr. Trotter.
19	MR. TROTTER: Do you want me to use the
20	microphone, your Honor, or can you hear?
21	JUDGE MOSS: I suppose it would be a good idea for
22	us to get in the habit of using the microphones, yes. Are
23	there microphones out there where you are, Mr. Meyer?
24	MR. MEYER: There are not.
25	JUDGE MOSS: We'll have to figure something about

- 1 that.
- 2 MR. TROTTER: We can pass them around. Donald T.
- 3 Trotter. I'm assistant attorney general representing the
- 4 Washington Utilities and Transportation Commission.
- 5 JUDGE MOSS: I believe public counsel is sitting
- 6 behind you there.
- 7 MS. SHIRLEY: Thank you, your Honor. Sarah
- 8 SHIRLEY, Assistant Attorney General for Public Counsel.
- 9 JUDGE MOSS: Pass it along to Mr. Sanger and just
- 10 carry across the room, please.
- 11 MR. SANGER: Irion Sanger. That's I-r-i-o-n,
- 12 Sanger, S-a-n-g-e-r. Appearing on behalf of the industrial
- 13 customers of Northwest Utilities, ICNU.
- MR. BROOKS: Good morning. My name is Tommy
- 15 Brooks, and I'm appearing on the behalf of the Northwest
- 16 Natural Gas Users.
- JUDGE MOSS: Welcome, Mr. Brooks.
- 18 MR. ROSEMAN: Hello. Good morning. My name is
- 19 Ronald Roseman, R-o-s-e-m-a-n. And I'm appearing on behalf
- 20 of the Energy Project.
- 21 MR. TRUE: Todd True, your Honor, on behalf of the
- 22 Northwest Energy Coalition.
- JUDGE MOSS: Welcome. Are there any others who
- 24 wish to enter appearances this morning in the hearing room?
- 25 Apparently not.

- 1 I understand that we do have a speaker phone in
- 2 the room, but I don't think anyone is on it presently. We
- 3 don't have the conference bridge line facility that we have
- 4 in Olympia, so we -- I'm not going to ask for appearances in
- 5 that fashion.
- 6 Judge Friedlander I think will be listening in on
- 7 that bridge -- on that conference line this afternoon, but
- 8 we will make her get off if we need to call Mr. Ebert, for
- 9 example, or utilize it in some other information.
- I am told that there is limited access to the
- 11 Ethernet or Internet cloud or whatever it is. So for those
- 12 of you who wish to try that, you can. I'll be trying it
- 13 later.
- 14 All right. The purpose of our hearings today is
- 15 twofold. One is that we will have a settlement hearing, the
- one Mr. Meyer referred to off the record a moment ago as a
- 17 technical hearing, what I will refer to as an evidentiary
- 18 hearing. We will do that this afternoon beginning at 2:30
- 19 in this room. And that will carry through as late as 5:00.
- 20 However, we also are here for purposes of
- 21 conducting public comment hearings so that we can hear from
- 22 members of the public, rate payers in particular, who may
- 23 have an interest and wish to convey that interest to us
- 24 through their oral comments.
- 25 And of course, we have received written comments

- 1 in connection with this case, which will become part of the
- 2 record.
- 3 So we will break this session here shortly and
- 4 travel to Spokane Valley. And in the council chambers
- 5 there, we will hold our first public comment hearing of the
- 6 day. And that is scheduled from noon to 1:30.
- 7 And then, as I mentioned, we will be returning
- 8 here by 2:30 to commence the evidentiary proceedings. And
- 9 we'll break by 5:00 for one hour.
- 10 And then at 6 o'clock, again in this room, we will
- 11 have a second public comment hearing today. And that's
- 12 scheduled to go as late as 7:30.
- 13 As you all know or many of you know, it -- the
- 14 length of the public comment hearings depends on how many
- 15 members of the public turn out and wish to speak. And so we
- 16 might go the full time or we might break early.
- Tomorrow, if we need to, we will convene here
- 18 early. I'll know that by the end of today at 5:00 or
- 19 before. And if we need to continue in the morning, I'll set
- 20 a time that works, taking into consideration that we need to
- 21 be in Pullman by noon tomorrow for our third public comment
- 22 hearing. And that's scheduled from noon to 12:30 in the
- 23 Pullman council chambers.
- 24 And presumably after that we will all go our
- 25 separate ways to our respective businesses or homes or what

- 1 have you. So that's our basic plan.
- 2 I would like to take care of a few preliminary
- 3 matters this morning, and if you all remind me if I miss
- 4 any. One is, as I read the file -- I understand that you,
- 5 the parties wish to stipulate in the pre-file direct
- 6 testimony exhibits that were submitted as part of this
- 7 filing. Is that correct?
- 8 MR. MEYER: That is correct, your Honor.
- 9 JUDGE MOSS: Okay. I have prepared an exhibit
- 10 list. It lists -- well, I shouldn't say that. Judge
- 11 Friedlander prepared an exhibit list that I believe contains
- 12 a list of those, and I'll provide them to the court
- 13 reporter.
- 14 THE REPORTER: I'm sorry?
- 15 JUDGE MOSS: You looked puzzled. I wanted to make
- 16 sure you got the record. You're okay? Okay. Good. All
- 17 right. So I will provide that to the parties and to the
- 18 court reporter by e-mail after we finalize it today.
- 19 In addition to those exhibits -- and I assume that
- 20 there is no objection to them or any of them? Hearing no
- 21 objection, they will be admitted as marked.
- 22 In addition we have the settlement stipulation the
- 23 parties filed, and we will mark that as Joint Parties
- 24 Exhibit 1. And we also have joint direct testimony of Kelly
- O. Norwood for Avista, Thomas E. Schooley for Commission

- 1 staff, Donald W. Schoenbeck for ICNU and Northwest
- 2 Industrial Gas Users, Lea Daeschel for Public Counsel, and
- 3 Charles M. Ebert for the Energy Project. And that will be
- 4 Joint Parties Exhibit 2.
- 5 Are there any other exhibits we need to mark? And
- 6 we need to save a place for the public comments, and that
- 7 will -- if there's no other joint exhibits, that will be
- 8 Joint 3. We'll append, but we'll get that later.
- 9 Okay. So with that -- and those, of course, I'm
- 10 sure will be admitted without objection. All of our
- 11 witnesses are not present this morning. So although I'd
- 12 planned to swear them this morning, we won't do that.
- This afternoon when we reconvene at 2:30, I think
- 14 the best plan will be to just have the witnesses come up
- 15 here, and we'll swear them and begin our proceedings.
- 16 As I understand it, the parties do not anticipate
- 17 the need for opening statements, but we will consider the
- 18 preferences the commissioners may have in that regard, and
- 19 I'll let you know this afternoon.
- I want to make one comment about what we're here
- 21 for today in terms of our more substantive proceedings, but
- 22 also, of course, in the sense for the public comment
- 23 hearings.
- 24 This is a proceeding now about the settlement
- 25 that's been filed. It is comprehensive, with the exception

- 1 of one issue that we call, for lack of a better description,
- 2 decoupling.
- 3 That aspect of the case or that issue will be
- 4 heard on its own schedule, which I understand as of
- 5 yesterday was still being worked out. So that's something
- 6 that we'll handle separately. I won't be mentioning it
- 7 again in these next two days.
- 8 I also want to remark that I understand, and the
- 9 commissioners understand, that some parties do not
- 10 affirmatively agree to every detail in the settlement, but
- 11 that no parties oppose any part of the settlement.
- 12 I don't see the need to say anything more about
- 13 that or hear anything from the parties about that, either.
- 14 I realize there may be some fine points, and you will want
- 15 to stand up and say, "Well, we don't agree with that
- 16 particular point." Well, that's not necessary. We're aware
- 17 of it and we will, of course, have it in mind as we consider
- 18 what to do in this case.
- 19 Are there any questions or any other matters of
- 20 business the parties would like to bring forth as a
- 21 preliminary issue now or a question?
- MR. MEYER: Yes, your Honor. Where's the
- 23 microphone?
- 24 JUDGE MOSS: I believe you did indicate there was
- 25 a correction to the testimony.

- 1 MR. MEYER: Right. We have a very minor
- 2 housekeeping matter. And we could defer this until the
- 3 commissioners are here so they could make the one edit in
- 4 their books, if you like.
- 5 JUDGE MOSS: That would make sense.
- 6 MR. MEYER: Let's do it then, because it's just a
- 7 wording change.
- JUDGE MOSS: Let's do that. Remind me.
- 9 MR. TRUE: Your Honor, I do have one procedure.
- 10 JUDGE MOSS: Come up to the mic.
- 11 MR. TRUE: Just -- Todd True for Northwest Energy
- 12 Coalition. You mentioned the schedule for the decoupling
- 13 proceedings, and we received an e-mail this morning with
- 14 some suggested dates for those hearings.
- 15 We have conferred here, and I believe there's an
- 16 agreement that the dates January 30th and 31st are good
- 17 dates for us. I would only add that I'm out of the country
- 18 the February dates. So if it's possible to do those January
- 19 dates, the Energy Coalition would appreciate it.
- JUDGE MOSS: Okay. And I would imagine that
- 21 e-mail came to you from Judge Friedlander?
- MR. TRUE: It did indeed.
- JUDGE MOSS: Well, I would say communicate back
- 24 with her that that's what you all wish to do, and she will
- 25 be handling that scheduling matter.
