**RE: Docket UE-210402—Errata to Joint Testimony Supporting the Stipulation**

PacifiCorp dba Pacific Power & Light Company (PacifiCorp) submits the enclosed errata to Exhibit No. JT-1CT, correcting one error on page 11 of the joint testimony. Specifically, in the Stipulation, parties specified that the net power cost update will reflect the latest electric and gas hedging and contract positions at the time of the update.<sup>1</sup> The language in the joint testimony, however, mistakenly stated that the electric and gas hedging and contract positions will be updated through December 31, 2021. This errata corrects that oversight to make the testimony consistent with the Stipulation.

PacifiCorp has conferred with the settling parties and has received authorization to make this errata filing on the settling parties' behalf.
