Amendment Number: 4


Description of amendment: : This Amendment deletes, changes and adds terms and conditions for certain UNEs as set forth in Attachment 1 and Exhibit A to this Amendment.

The amendment amends the interconnection agreement first approved by the Commission on June 28, 2000 (date) in WUTC Docket No. UT-003034 (original docket number).

Company A represents that the amendment does not discriminate against non-party carriers, that it is consistent with state and federal law, and that it is in the public interest. The Commissioners, having reviewed the information available in this matter and having determined this Order to be consistent with the public interest, directed the Secretary to enter this Order.
