SUBORDINATE AGREEMENT

This Subordinate Agreement is made by and between Verizon Services Organization Inc. ("Customer") and MCI WorldCom Network Services, Inc. (Provider) and is subordinate to and incorporates the terms and conditions of that certain Telecommunications Services Agreement (Contract No. TSA010302-1) (the "TSA"). Capitalized terms not defined herein shall have the meaning ascribed to them in the TSA.

WHEREAS, Customer originally ordered and continues to receive certain private line services from Intermedia Communications, Inc. ("ICI"), which Services are provided under Account Numbers 7000255605, 3000031484 and 3000031432, and are more particularly described by Circuit ID as shown on Attachment A, attached hereto and incorporated herein by reference (the "Services");

WHEREAS, Customer agrees to continue receiving and paying for the Services at the existing pricing, which is set forth on Attachment A;

WHEREAS, ICI, which is an affiliate of Provider, and Provider have agreed that Provider will continue to provide the Services to Customer;

WHEREAS, Customer and Provider desire to transition the Services to the TSA, and have the Services subject to all of the terms and conditions of the TSA, except for the existing rates, which are set forth in Attachment A, and any other charges and service commitment periods which may currently be in effect;

NOW, THEREFORE, in consideration of the mutual promises which follow and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties, intending to be legally bound hereby, agree as follows.

1. SCOPE

The parties desire to have the Services set forth in Attachment A of this Subordinate Agreement made subject to the terms and conditions of the TSA and each Party acknowledges and agrees that it will be bound by the terms and conditions of the TSA and this Subordinate Agreement in connection with the Services. Until such time as the Parties mutually agree to migrate the Services to Provider's Option 1 network and/or otherwise re-price the Services by mutual written agreement, the parties agree that the monthly recurring charges for the Services set forth in Attachment A shall remain in effect until the effective date of any such migration and/or re-pricing. The Services shall also continue to be subject to any other charges currently in effect or applicable minimum service commitment periods which may be in effect as of the effective date of this Subordinate Agreement.

2. TERM

The effective date of this Subordinate Agreement shall be May 1, 2005 and shall run coterminous with the TSA.

3. PRECEDENCE OF DOCUMENTS

In the event there is any conflict between the terms and conditions of this Subordinate Agreement and the TSA the terms and conditions of this Subordinate Agreement shall govern.

4. AUTHORITY

Each party represents to the other party that it has full power and authority to effect the transition of the Services to the TSA as described herein and agrees to indemnify the other party for any claims against such other party arising out of or related to the execution of this Subordinate Agreement and such transition.
