NOTICE SUSPENDING PROCEDURAL SCHEDULE

AND

NOTICE REQUIRING FILING OF SETTLEMENT DOCUMENTS OR STATUS REPORT (By April 12, 2019)

On February 27, 2019, the Washington Utilities and Transportation Commission (Commission) entered a Complaint for Penalties and Order of Consolidation; Notice of Brief Adjudicative Proceeding (Complaint Order) against Leavenworth Shuttle & Taxi, LLC (Leavenworth Shuttle or Company). The Complaint Order alleged that during a compliance review in November 2018, Commission staff (Staff) found that Leavenworth Shuttle had violated eight different provisions of Title 49 C.F.R., several of which were repeat violations that contravened the conditions of Order 01 in consolidated dockets TE-161020 and TE-161021 (Order 01). Order 01 suspended \$10,000 in penalties against the Company on the condition that Leavenworth Shuttle not incur any repeat violations of WAC 480-30-221.

The Complaint Order scheduled a brief adjudicative proceeding in these consolidated dockets for April 10, 2019.

On April 2, 2019, Staff notified the Commission that the parties had reached a settlement in principle. Staff requests on behalf of the parties that the procedural schedule in this matter be suspended and that the parties be permitted to file a settlement agreement or status report no later than April 12, 2019.

The Commission finds good cause to suspend the procedural schedule and therefore grants the parties' request. The parties must either file a settlement agreement and supporting documentation or a report on the status of their settlement negotiations by April 12, 2019.

THE COMMISSION GIVES NOTICE That the procedural schedule in this matter is suspended and the brief adjudicative proceeding scheduled for April 10, 2019, is cancelled. By April 12, 2019, the parties must either file a settlement agreement and supporting documentation or a status report of their negotiations.
