NOTICE CANCELLING BRIEF ADJUDICATIVE PROCEEDING, SUSPENDING PROCEDURAL SCHEDULE,

and

REQUIRING STATUS REPORT FILING (By August 9, 2019)

RE: In the Matter of the Application of We Like to Move It, Move It!! LLC for a Permit to Operate as a Motor Carrier of Household Goods – Docket TV-170176

TO ALL PARTIES:

On May 31, 2019, the Washington Utilities and Transportation Commission (Commission) issued a Notice of Intent to Cancel the Household Goods Carrier Permit of We Like to Move It, Move It!! (We Like to Move It or Company). The Notice was based on the Company's alleged failure to attend a Commission-sponsored household goods training, a necessary requirement for attaining permanent authority to operate.

On June 5, 2019, Commission staff (Staff) filed with the Commission a letter stating that the Company intends to attend the Commission-sponsored household goods training on August 7, 2019, and requesting the Commission cancel the brief adjudicative proceeding (BAP) set for June 11, 2019. Staff recommends that the Commission grant the Company the opportunity to come into compliance with WAC 480-15-305(1)(c) by attending the August 7, 2019, training. Thereafter, Staff would submit a report to this docket concerning the Company's attendance. Accordingly, Staff recommends the Commission cancel the BAP, suspend the procedural schedule, and set a deadline of August 9, 2019, for Staff to submit a status report.

Based on the parties' agreement and the Company's representation that it intends to come into compliance, the Commission finds good cause to cancel the BAP scheduled for June 11, 2019, suspend the procedural schedule, and require Staff to file a status report concerning the

Company's attendance at the August 7, 2019, Commission-sponsored household goods training by August 9, 2019.

THE COMMISSION GIVES NOTICE That the brief adjudicative proceeding scheduled for June 11, 2019, at 1:30 p.m. in Docket TV-170176 is cancelled.

THE COMMISSION GIVES NOTICE That the procedural schedule in Docket TV-170176 is suspended.

THE COMMISSION GIVES NOTICE That Staff must file a status report in this docket by August 9, 2019, concerning the Company's attendance at the August 7, 2019, Commission-sponsored household goods carrier training.
