Let us explain again, that one of our Web Developer who built website at the domain <a href="https://www.seattle7dayslimo.com">www.seattle7dayslimo.com</a>, has left the job after updating the website (for year 2017) on 2nd Dec 2016. Later when you contacted us to make changes in the website, we get to know that he mistakenly erased the data from his system containing the access credentials for the domain. Let me clear it that no one can access the domain, without having login information.
