Cheung, Exhibit SLC-4.

Table 1 in Exhibit ALB-3T at 2 represent the Washington-allocated equivalent of the total-Company figures reflected on page 135 of Exhibit SLC-4.

Please refer to Attachment PC 280 which provides the requested break down of amounts between distribution and transmission in the same format as on page 135 of Exhibit SLC-4.

Note: In preparing the responses to this set of data requests on wildfire mitigation and vegetation management expenses from Public Counsel, the Company observed a mis-categorization of costs originally presented on page 135 of Exhibit SLC-4, and subsequently in Table 1 of Exhibit ALB-3T. Specifically "PP Vegetation – Admin." costs inadvertently included "Situational Awareness – Subscription & Software" amounts. Attachment PC 280 provides a corrected categorization. Expense amounts in total reflected in the Company's filing remains accurate, this correction is limited to a categorical error.
