### Response to WUTC Data Request 71

The difference between the direct testimony of Ms. Natasha C. Siores and the information provided in PacifiCorp's supplemental response to WUTC Data Request 16 is due to the difference in the base year used to index the inflation data by IHS Global Insight and the base year used to index data in this case.

The data shown in the column labeled "2013" in PacifiCorp's 1<sup>st</sup> supplemental response to WUTC Data Request 16 is based on an index of 2012 = 1.000. The data shown in the column labeled "2013" in Exhibit NCS-8C to the direct testimony of Natasha C. Siores, is based on an index of 1992 = 1.000.
