**VIRGIN MOBILE USA, L.P. MOTION TO AMEND
ORDER NOS. 01 AND 02
TO REFLECT NAME CHANGE
TO ASSURANCE WIRELESS USA, L.P.**

Virgin Mobile USA, L.P. (“Virgin Mobile” or “Company”) hereby submits this Motion to request that the Commission, pursuant to RCW 80.04.210 and WAC 480-07-875, amend its prior orders in this Docket, Order Nos. 01 (10/10/10) and 02 (10/16/14), to reflect a corporate name change in which, effective February 18, 2020, Virgin Mobile USA, L.P. underwent a name change to become Assurance Wireless USA, L.P. This name change is not a result of a corporate reorganization or merger or the result of any structural changes that impacts the operations of the Company in way. Lifeline customers will continue to receive service exactly as before with no changes to rates, terms or conditions of service. The name change will have no impact on the operations of the Company in the state of Washington, and will in no way impact its compliance with the federal and state laws and regulations impacting its designation as an Eligible Telecommunications Carrier (“ETC”) in the state of Washington.

On October 10, 2010, this Commission issued Order No. 01 in this Docket in which it designated Virgin Mobile an ETC for certain areas in Washington. On October 16, 2014, this Commission issued Order No. 02 in this Docket in which it granted Virgin Mobile's request for continued designation as an ETC and an exemption from WAC 480-123-030(1)(d) subject to the conditions in Appendix A.

On February 18, 2020, Virgin Mobile USA, L.P., a Delaware limited partnership, underwent a name change to become Assurance Wireless USA, L.P., also a Delaware limited partnership. The name change to Assurance Wireless USA, L.P. was accomplished through the filing of a Certificate of Amendment of Limited Partnership in Delaware. No other changes to the entity occurred, including any merger, transaction, or other structural change, nor were there any changes to the ownership or operations of Virgin Mobile (now Assurance Wireless USA, L.P.) Attached hereto as **Exhibits 1 and 2**, respectively, are copies of Assurance Wireless USA, L.P.'s Delaware Certificate of Amendment of Limited Partnership, and Assurance Wireless USA, L.P.'s Amended Certificate of Limited Partnership filed at the Secretary of State for the State of Washington on February 21, 2020.

This name change will have no customer impact – no current Lifeline rates, terms or conditions of service will change as a result of the name change to Assurance Wireless USA, L.P. In addition, the name change will not be confusing to customers because Virgin Mobile's Lifeline service operates under the brand name "Assurance Wireless brought to you by Virgin Mobile." The name change to Assurance Wireless USA, L.P. simply aligns the name of the legal entity with the familiar brand name.

For the foregoing reasons, Virgin Mobile requests that the Commission issue an Order modifying Order Nos. 01 and 02 to recognize the name change to Assurance Wireless USA, L.P. on its ETC designation and to update all applicable Commission records to reflect the name change.

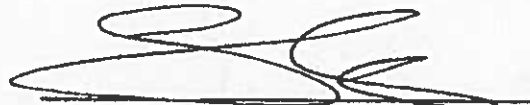
