- On April 29, 2004, Kitsap Ferry Company, LLC d/b/a Kitsap Ferry Co. (Kitsap Ferry or Applicant) filed an application (No. B-079276) for a temporary certificate of authority to provide passenger-only ferry service (Application), between Bremerton and Seattle. Notice of the Application was published in the Commission's weekly docket of May 17, 2004. The Commission granted the application for temporary authority on May 7, 2004, pursuant to the authority in WAC 480-51-060(1) and (3).
- On May 21, 2004, the Inlandboatmen's Union of the Pacific filed a protest against the application pursuant to WAC 480-51-060(5). The protest contends that the grant of temporary authority was improper. A more specific statement of the issues raised in the protest is set out in the protest, which is available from the Commission upon request and is posted on the Commission's web site at www.wutc.wa.gov.
- Pursuant to RCW 34.05.482, WAC 480-07-610, and WAC 480-51-060, the Commission determines that a brief adjudicative proceeding is appropriate for this matter.
- The Commission has jurisdiction over this matter under Title 81 RCW, which authorizes it to regulate persons seeking to furnish commercial ferry service

under chapter 81.84 RCW and chapter 480-51 WAC. The issues in this proceeding include whether and to what extent the protest is valid, and whether the protest is sufficient. The ultimate issue posed in this matter is whether granting the temporary certificate to Kitsap Ferry for the service it proposes was due to an immediate and urgent need, and was otherwise consistent with the public interest as required in RCW 81.84.070 and WAC 480-51-060, considering relevant factors including the factors listed in WAC 480-51-060(3).

- Statutes involved include those within chapter 81.04 RCW, chapter 81.84 RCW, and chapter 34.05 RCW, including but not limited to RCW 34.05.431, RCW 34.05.434, RCW 34.05.437, RCW 34.05.440, RCW 34.05.443, RCW 81.84.010, RCW 81.84.020, and RCW 81.84.070. Rules involved include those within chapter 480-07 WAC and chapter 480-51 WAC, including but not limited to WAC 480-51-060.
