I would like to quickly address the petition for review that was filed by Allstar and request that the petition be denied on the basis of false representation by Allstar movers, LLC and clear customer confusion and unfair competition.


It is clear that Allstar Movers, LLC is trying to avoid changing their name because they are enjoying unjust riches due to the overlapping use of the mark with All Star Transfer aka All Star Movers. I made a very clear case in court that the reason for my protest of Allstar Movers original application for temporary permit was that we operated under the name All Star Movers prior to receiving our permit and built substantial customer recognition under that mark. Allstar Movers, LLC claims that the reason for my protest was the existence of All Star Moving in Spokane. This is not true and appears to be an attempt to manipulate the court.

Allstar Movers, LLC also falsely claims that our areas do not overlap when they clearly do. We, All Star Transfer, have been doing business and advertising, both via internet and yellow pages, in pierce county for the duration of our business since 1996. We continue to do so today. Allstar movers, LLC has been doing business as far north as Marysville which far overlaps our main office in Edmonds, WA. Mr. Lucas made false claims to the court with respect to this.

We supplied evidence that was very real to show that we operated and continue to operate under a very similar name in the same areas. Allstar movers, LLC should not be granted a second hearing based on false statements. We would be happy to provide any information to the court, to help expedite the process but it seems very clear that there are no grounds for another hearing and I ask the court to review the evidence if necessary and make that finding.

If another hearing is necessary, I will have customers present to the extent that I can to testify in person of their confusion between the companies and of Allstar Movers, LLC operations in areas far outside of their statements. I thank you for the courts consideration on this matter.
