This letter is to inform you of the progress made in this rulemaking docket concerning possible adoption of proposed revisions to the requirement related to distribution of telephone books in WAC 480-120-251 Directory service. This letter also provides notice of an opportunity to file written comments on the proposed rule amendments and to participate in the formal rule adoption hearing scheduled for 9:30 a.m. on Wednesday, September 12, 2012.

On July 18, 2012, the Washington Utilities and Transportation Commission (Commission) filed a Notice of Proposed Rulemaking (CR-102) in this docket with the Code Reviser regarding modifications to, or the elimination of, the requirement that local exchange companies provide each customer a copy of a telephone directory for the customer's exchange area. The Commission developed the proposed rule revisions with the benefit of stakeholder comments received on May 21, May 23, and June 16, 2012, which are available in this docket on the Commission's website <a href="http://www.utc.wa.gov/120451">http://www.utc.wa.gov/120451</a>.

The CR-102 begins the final part of the rulemaking process, which includes a written comment period, a public adoption hearing, and a decision by the Commission.
