Dear Sir or Madam:

As you are aware, on June 9, 2015, the Washington Utilities and Transportation Commission issued a Penalty Assessment against Bremerton-Kitsap Airporter, Inc. in the amount of \$1,000 for violation of WAC 480-30-221, which requires passenger transportation companies to comply with federal motor carrier safety regulations concerning controlled substances and alcohol use and testing. On June 30, 2015, the Commission entered Order 01, denying a request for mitigation and upholding the penalty assessment. On August 5, 2015, the Commission issued Order 02, Final Order Upholding Order 01. As of August 17, 2015, Bremerton-Kitsap Airporter, Inc. has not paid the \$1,000 penalty. The Commission sent you a Final Notice dated September 2, 2015, indicating that the balance of \$1,000 was due.

The Commission has not received the \$1,000 payment due and owing.

This is to notify you that the Commission intends to forward your outstanding debt to a collection agency for collection. You likely will incur additional expenses and fees, including costs of collection, attorney's fees, and interest. These expenses and fees will be added to your outstanding \$1,000 balance.

He began working for us on August 27, 1998.

I hope this clarifies the matter and establishes our "innocence" as I do not intend to devote any more time to this.
