TO ALL INTERESTED PERSONS:

This letter is to inform you of the status of the Utilities and Transportation Commission (Commission) rulemaking to implement Engrossed Substitute House Bill (ESHB) 1105, Chapter 333, Laws of 2017, to establish rules for railroad contract crew transportation providers. This letter also provides notice of an opportunity to file written comments on the proposed rules and to participate in the formal rule adoption hearing scheduled for Monday, April 12, 2018, at 1:00 p.m.

On July 20, 2017, the Commission filed a Preproposal Statement of Inquiry (CR-101) in this docket with the Code Reviser to consider adoption of rules to implement ESHB 1105. To date the Commission has completed the following steps in the rulemaking process:

- 1. On July 21, 2017, issued:
 - CR-101, Preproposal Statement of Inquiry.
 - Notice of Opportunity to File Written Comments by August 28, 2017.
 - Notice of Workshop set for October 5, 2017.
- 2. Received comments from Professional Transportation, Inc. (PTI) and the
- 3. United Transportation Union (UTU) in response to the July 21, 2017, notice.

4. On October 5, 2017, held a workshop attended by stakeholders BNSF Railway (BNSF), United Transportation Union (UTU) representing railroad workers, and Professional Transportation, Inc. (PTI), a currently contracted crew transportation company serving both BNSF and Union Pacific Railroad.

- 5. Received comments from Mike Elliott (private citizen and railroad employee) in response to the workshop.
- 6. On November 20, 2017, issued draft rules and Notice of Opportunity to Submit Written Comments by Friday, December 22, 2017.
- 7. Received comments from BNSF and comments from UTU in response to the November 20, 2017, notice of draft rules.
- 8. On November 20, 2017, issued Notice of Opportunity to Respond to Small Business Economic Impact Statement (SBEIS) Questionnaire by Friday, December 22, 2017. The Commission receive
- 9. d no comments in response to the SBEIS Questionnaire.

On Friday, February 23, 2018, the Commission filed a Notice of Proposed Rulemaking (CR-102) with the Office of the Code Reviser, including draft rules that reflect the work done to date. The proposed rules add sections to Chapter 480-62 WAC and amend other sections within the chapter. The proposed rules are available for inspection on the Commission's web page at http://www.utc.wa.gov/170780. The CR-102 filing initiates the final part of the rulemaking process which includes a written comment period, a public adopt hearing, and a decision by the Commission regarding final rules.
