Dear Director and Secretary Killip:

Commission Staff has requested Cascade Natural Gas Corporation (“Cascade”) correct and resubmit certain items in Cascade’s initial filing in the above-captioned docket. In consultation with Staff, Cascade submits replacement versions of two exhibits and provides one supplemental work paper to address Staff’s identified concerns regarding text searchability and link errors.

In general, with respect to text searchability, Cascade used Optical Character Recognition (“OCR”) technology to identify text. But in some instances, the OCR technology could not identify text due to the quality or nature of the text, as specified below.
