

Seattle Steam Company has intervened in many of Puget Sound Energy's (PSE) rate proceedings going back many years. For decades Seattle Steam has been one of PSE's largest gas transportation customers, and its business has depended on maintaining reasonable gas transportation costs. But, because of ever-increasing costs of gas and gas transportation, Seattle Steam has invested heavily to convert one of its boilers to be fueled by wood waste and wood biofuels. The result of that investment was to substantially reduce Seattle Steam's gas consumption and thus its justification for participating in PSE rate cases.

It reserves its right to participate in future cases and asks that it continue to receive notice of future rate cases. However, it does not intend to intervene in this proceeding.
