PacifiCorp objects to the extent that these data requests are based on the assumption that Order 09 imposes an evidentiary standard mandating the creation, retention, and/or production of certain documentation. Based on the foregoing assumption, and without waiving the foregoing objection, PacifiCorp responds and follows:
