SECTION ONE

RULES AND REGULATIONS

RULE NO.

1. a. ADULT FARES - Fares published herein are adult fares and apply to passengers who have reached or passed the age of their 13th birthday.

b. ADDITIONAL ADULT FARES - When two or more adults are traveling together the charge for the second (or more) adults will be as shown for each additional adult.

2. CHILDREN'S FARES - One child 12 years and under accompanied by a fare paying adult will be carried free. Additional children will be carried at the additional adult rate.

EXCEPTION: Scheduled service only: Children under 6 years of age accompanied by an adult will be carried free. Children 6 years thru 12 years accompanied by an adult will be charged according to the rates shown on page Three B.

3. STOP-OVER FARES - Stop-over fares will not be permitted on any portion of the route.

4. ROUND TRIP FARES - Fares will be sold on a one way basis only.

5. TICKET REDEMPTION - Unused tickets or portions thereof will be redeemed when presented to the original issuing party.

6. BAGGAGE RULES & CHARGES - Baggage will be limited to two pieces per fare paying passenger, each piece not to exceed 70 pounds and/or 62 inches total dimensions. Also one hand carry not to exceed 45 inches total dimensions. Additional pieces and/or oversize may require private charter.

BAGGAGE LIABILITY - As provided by Washington State law (RCW 81.25.050), unless a higher value is declared prior to transportation and agreed to in writing by ShuttleExpress, the following property damage liability will apply.

Suitcases . . . . \$50.00 All other Items . . \$50.00.

EXCESS VALUATION - If a passenger declares a greater value than above specified in this rule there will be a charge at the rate of \$.50 for each additional \$100.00 valuation or fraction thereof not to exceed \$200.00.

NOTIFICATION OF LOSS OR DAMAGE - ShuttleExpress must be notified, in writing, of any loss or damage within 24 hours of transportation.

7. SCHEDULE MAINTENANCE - Carrier will not be liable for delays caused by accident, breakdown, bad conditions of roads, snow storms and other conditions beyond it's control and does not guarantee to arrive at, or depart from any point at any specific time unless optioned by the carrier on a individual basis.

8. OBJECTIONABLE PASSENGERS - The company reserves the right to refuse to transport persons under the influence of intoxicating liquor or drugs, or is incapable of taking care of themselves, or whose condition, conduct or behavior may be objectionable to other passengers.

9. ANIMALS - Dogs, cats, and other animals or birds will be carried when in an appropriate container with outside dimensions not to exceed 27"long x 20" wide x 19" high.

Exceptions - "Seeing Eye", "Hearing Impaired" and certified "Search" dogs, when properly harnessed or leashed, will be carried free of charge. The dogs will not be permitted to occupy a seat but must lie at the feet of it's master.

10. GROUP/CONVENTION RATES - Parties of 15 or more who make prior arrangements for transportation shall be eligible for \$1.00 off per passenger.

## APPENDIX A

### PASSENGER AND EXPRESS AIRPORTER SERVICE

Between: The Seattle-Tacoma International Airport, Boeing Field, Renton Airport, and Paine Field and points within the Seattle Commercial Zone in King and Snohomish Counties and excluding points in Kitsap and Pierce Counties, described as follows:

(a) the municipality of Seattle; excluding service to or from the following hotel and/ or motels

The Stouffer Madison Hotel, Crown Plaza, Four Seasons Olympic, Seattle Hilton, Seattle Sheraton, Westin, Warwick, Loyal Inn, Quality Inn, Days Inn, Downtown Travelodge and Best Western Executive Inn.

(b) all points within a line drawn fifteen miles beyond the municipal line of Seattle;

(c) those points in King County which are not within the area described in (b) of this subsection and which are west of a line beginning at the intersection of the line described in (b) of this subsection and Washington Highway 18, thence northerly along Washington Highway 18 to junction of Interstate Highway 90, thence westerly along Interstate Highway 90 to the junction of Washington Highway 203, thence northerly along Washington Highway 203 to the King County line; and those points in Snohomish County, which are not within the area described in (b) of this subsection and which are west of Washington Highway 9.

(d) All of any part of which is within the limits of the combined areas defined in (b) and (c) of this subsection; and

(e) all of any municipality wholly surrounded, or so surrounded except for a water boundary, by the municipality of Seattle or by any other municipality included under the terms of (d) of the subsection. Between: The Seattle-Tacoma International Airport, Boeing Field, Renton Airport and Paine Field and points in Kitsap and Pierce Counties.

Between: The Seattle-Tacoma International Airport and points in Pierce County, excluding service to or from Fort Lewis Army Base and McChord Air Force Base.

### RESTRICTIONS:

1) This authority may not be transferred for three years from the date of issue.

2) The carrier may offer only on-call, door to door type service between airports served and any points within the territory served including residences, hotels and businesses.

3) Service may be provided in vehicles no larger than a seven passenger van.
