By this letter, and pursuant to WAC 480-07-385(2)(a), Commission Staff (Staff) respectfully requests that the Commission continue the prehearing conference in consolidated Dockets TV-190593 and TV-190594, presently set for 2:00 p.m. on November 12, 2019, to the afternoon of November 18, 2019.

The Commission "will grant a continuance if the requesting party demonstrates good cause for the continuance and the continuance will not prejudice any party or the [C]omission." The Commission will grant continuances only to a specified date.²

On October 23, 2019, the Commission issued an Order of Consolidation, Notice of Intent to Deny Applications for Permanent Authority, Notice of Intent to Deny Petitions for Exemption, and Notice of Prehearing Conference (Set for November 12, 2019, at 2 p.m.) in the abovereferenced dockets. Conflicts have since developed that will prevent members of Staff from attending the conference as currently scheduled.
