It has come to our attention that Puget Sound Energy (“PSE”) inadvertently filed its November 2020 through October 2021 monthly Purchased Gas Adjustment (“PGA”) reports pursuant to WAC 480-90-233(5) in its 2019 PGA docket (UG-190218).

Attached for re-filing in PSE’s 2020 PGA docket (UG-200832) are the same November 2020 through October 2021 monthly PGA reports. Since the balances in PSE’s 2020 PGA docket included amounts from supplemental Schedule 106A (UG-190218) in its 2020 PGA docket, and also include the recovery of balances under Schedule 106B, per PSE’s 2019 General Rate Case (“GRC”) Final Order 08 per Dockets UE-190529 and UG-190530 (consolidated), paragraph 662, we also reference those dockets above.

PSE’s November 2021 through October 2022 monthly PGA reports will be filed in both its 2021 PGA docket (UG-210721) and its 2019 GRC docket (UG-190530).
