Pursuant to the procedural schedule for the above entitled docket, the Public Counsel Unit of the Washington Office of the Attorney General (“Public Counsel”) respectfully submits this report regarding the status of Cascade Natural Gas Corporation’s (“Cascade” or “Company”) Customer Notice. In an earlier report filed in this docket on October 2, 2020, Public Counsel stated that it would submit a subsequent Customer Notice Report on Friday, November 13, 2020.

In October and early November of 2020, the parties finalized the Customer Notice ensuring that the Notice provided sufficient information to comply with the July 13, 2020, Prehearing Conference Order in this proceeding and the requirements of WAC 480-90-194, 480-90-197, and 480-90-198. The Customer Notice explains the Company’s rate request and provides information to customers on how to participate during the Public Comment Hearing set for January 26, 2020 in this docket. The hearing will be conducted through a Microsoft Teams link or by phone to ensure public participation consistent with Covid-19 concerns.

On November 6, 2020, the Company filed with the Commission copies of the customer notice and public announcement discussing the public comment hearing. The Company will include the customer notice as an attachment to customer bills in the bill cycle beginning on November 20, 2020 so that all customers will receive proper notice ahead of the January 26, 2021 Public Comment Hearing date.
