i-wireless, LLC hereby provides notice of changes to its Lifeline offering, summarized in Attachment A attached hereto, effective December 1, 2020 in accordance with changes in the Federal Communications Commission's minimum service standards.¹

New customers and existing customers who have a smart device receive the updated Broadband Bundle with 1,000 voice minutes, unlimited text messages and 4.5 GB data. Existing customers without a smart device retain their existing benefits which meet voice-only minimum service standards. Tribal customers receive unlimited talk, text and 5.5 GB data.

The Order waived the Lifeline minimum mobile broadband service standard to the extent it would require mobile carriers in the Lifeline program to offer more than 4.5 GB per month, but did not pause the scheduled phasedown of support for Lifeline voice service.
