Description of amendment: This Amendment deletes certain UNEs as set forth in Attachment 1 and Exhibit A to this Amendment, attached hereto and incorporated herein by this reference.

The amendment amends the interconnection agreement first accepted by the Commission on 5/26/04 (date) in WUTC Docket No. UT-043028 (current docket number). That agreement was originally approved by the Commission on 8/28/2000 (date) in WUTC Docket No. UT-003006 (original docket number) between Qwest Corporation and Sprint Communications Company (Name of company C).

Company A represents that the amendment does not discriminate against non-party carriers, that it is consistent with state and federal law, and that it is in the public interest. 
WASHINGTON UTILITIES AND TRANSPORTATION COMMISSION
