TO ALL PARTIES OF RECORD:

The Washington Utilities and Transportation Commission (Commission) entered its Order 06, Final Order Rejecting Tariff Sheets; Approving and Adopting Settlement Stipulation; Requiring Compliance and Subsequent Filings in this docket on December 16, 2011. The Order, among other things, rejected a tariff proposal by Avista Corporation d/b/a Avista Utilities (Avista), but authorized Avista to file tariff sheets consistent with the terms of Order 06. The Order also authorized the Commission's Secretary to approve the authorized filing by letter if it complied with the terms of the Order.

On December 20, 2011, Avista filed electric and natural gas tariff sheets as specified in the Order. A list of the tariff sheets is attached to this letter. The Commission has examined the filing and it appears to comply with the terms of the Order.
