The Washington Utilities and Transportation Commission (Commission) entered its Order 06, Final Order Rejecting Tariff Sheets; Approving and Adopting Settlement Stipulation; Requiring Compliance and Subsequent Filings in this docket on December 16, 2011. The Order, among other things, rejected a tariff proposal by Avista Corporation d/b/a Avista Utilities (Avista), but authorized Avista to file tariff sheets consistent with the terms of Order 06.
