Enclosed please find the revised Response Testimony of Dr. J. Randall Woolridge, Exh. JRW-1Tr, on behalf of Public Counsel. After filing, we discovered some errant language that was not updated as intended as well as some formatting errors. Below is a detailed list of the revisions made:
