Amendment Number: 1

Description of amendment: Makes amendments related to the Federal Communication Commission's Triennial Review Remand Order.

The amendment amends the interconnection agreement first accepted by the Commission on 11/08/2000 in WUTC Docket No. UT-003115 (with regard to GST Telecom Washington Inc., which Company B has succeeded). That agreement was originally approved by the Commission on 5/12/1999 in WUTC Docket No. UT-980370 between Company A and Company C, Electric Lightwave, Inc.



- (3) The laws and regulations of the State of Washington and Commission Orders govern the construction and interpretation of the Amended Agreement. The Amended Agreement is subject to the jurisdiction of the Commission.

The Commissioners, having reviewed the information available in this matter and having determined this Order to be consistent with the public interest, directed the Secretary to enter this Order.
