In addition to the foregoing statutes, rules involved include those within chapter 480-09 WAC relating to practice and procedure. The ultimate issue involved is whether the public safety requires an order be entered authorizing the modification of a grade crossing surface of the above-described crossing, and if so, how the expense of such a change should be apportioned between the railroad and the county.
