Present provisions are: SUPPLEMENTS 2 THROUGH 8 ADD THE VARIOUS CITY AND TOWN TAXES TO THE CHARGES FOR REFUSE SERVICE PROVIDED TO CUSTOMERS LIVING WITHIN THE RESPECTIVE CITIES AND TOWNS. THE TOWN OF GRANGER PASSED ORDINANCE 961 ON JANUARY 8TH, 2002 WHICH LEVIES A 6% TAX ON ALL REFUSE COLLECTION SERVICES CONDUCTED WITHIN ITS TOWN. THERE IS NO PRESENT PROVISION FOR THE TOWN OF GRANGER TAX IN TARIFF NO. 8.

Proposed changes are: CANCEL SUPPLEMENTS 2 THROUGH 8 AND ADD A TAXES SHEET, PAGE 2A, TO CONSOLIDATE ALL CITY AND TOWN TAXES ON THE TAXES SHEET AND ADD THE TOWN OF GRANGER TAX IN THE AMOUNT OF 6%.

YAKIMA WASTE IS CURRENTLY SERVING 18 ACCOUNTS WITHIN THE TOWN OF GRANGER. THE ORDINANCE PASSED WAS EFFECTIVE UPON PUBLICATION, THEREFORE, YAKIMA WASTE IS REQUESTING AN EFFECTIVE DATE WITH LESS THAN STATUTORY NOTICE.
